

ORDINANCE No. 2023-12-07
WAYNE TOWNSHIP ROAD DISTRICT
TAX LEVY ORDINANCE

An ordinance levying taxes for all road purposes for the Wayne Township Road District, DuPage County, Illinois, for the tax year 2023, collectable in 2024.

BE IT ORDAINED by the Board of Trustees of Wayne Township, DuPage County, Illinois, as follows:

\$1,790,157

SECTION 1: That the Highway Commissioner of Wayne Township Road District does hereby determine and declare the sum of **One Million Seven Hundred Ninety Thousand One Hundred Fifty Seven Dollars** are hereby levied upon all property subject to taxation within the road district as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the road district as required by statute or voted by the people in accordance with the law, for such purposes as:

Road and Bridge Fund

Social Security Fund

Permanent Hard Road Fund

Illinois Municipal Retirement Fund

Building and Equipment Fund

Tort Liability/Insurance Fund

SECTION 2: That the amount levied for each object and purpose shall be as follows:

1. ROAD & BRIDGE FUND

Administration \$ 10,000

2. PERMANENT HARD ROAD FUND

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for the Wayne Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
