The Supervisor stated 3.4% is needed to carry the Township through to June. The expansion has increased the costs for insurance and utilities. General Assistance will also need to increase personnel to effectively handle their clients.

Trustee Waghorne asked Highway Commissioner Martin McManamon why he is levying flat this year after he raise taxes the past two years. The Highway Commissioner stated it wasn't needed with upcoming projects and projected costs. He is awaiting notification next month if Road will receive the grants, he applied for the bike path on Klein Road and for the bridge.

C. 2025 Health Insurance Renewal for Town & Road

The Board reviewed the information provided about the health policy renewals for Town and Road. The 2025 health insurance rate increased by 10.44% for Town and 10.73% for the Road District with no increase for dental, vision or life. Trustee Hempel questioned why other policy options were not provided again this year for the board to compare. He would like options and stated it is hard to vote "all or nothing". Trustee Parent asked Supervisor Ramey for clarification about the summary provided by the Director Finance and Administration stating employees pay 20% of the first \$2,000 deductible and the township's responsibility of paying the remaining balance.

Trustee Waghorne motioned to approve the 2025 health insurance renewal for town and road.

D. Special Police Contract for FY2025-2026

DuPage County sent a notice that the cost of the special police cost would increase from \$137,656.92 to \$140,298.44 for FY2025-20026. The board discussed and will await receiving the contract from the county.

E. <u>Resolution 2024-11-07A Setting Compensation of Township Officials for the Four-Year Term Beginning May 19, 2025</u>

The board reviewed the proposed resolution regarding elected officials' salaries for the next 4-year term. The proposed annual compensation for elected positions: Supervisor: \$49,000.00, Clerk: \$20,000.00, Trustees: \$4,500.00, Assessor: \$130,000.00 and Highway Commissioner: \$108,000.00. Supervisor Ramey reminded all salaries are to be set based on the position and not who is the elected official. After reviewing the salaries, Trustee Hempel stated that he thought that trustees should be decreased.

Highway Commissioner Martin McManamon asked to address the board. McManamon stated he is a source of knowledge amongst fellow commissioners and the last setting of salaries was political when he did not receive a pay increase. The Highway Commissioner stated Trustee Waghorne advocated for an increase for the Commissioner and only Assessor Musson receive an increase. He went on to compare the hourly rate trustees receive based on meetings and what the payrate would increase to with the proposed salary for the next for years. The Highway Commissioner reminded the board that his position requires working holidays and weekends. Assessor Michael Musson also addressed the board. The Assessor referenced information he sent the board prior to the meeting. He provided a handout with similar sized township comparisons regarding their assessor's pay and coverage:
