## 11. SUPERVISOR'S ADDRESS

Supervisor Ramey and Clerk Ramundo attended the Township Officials of Illinois Conference in November. The Supervisor congratulated Clerk Ramundo on being elected to TOI's Clerks Division Board. Clerk Ramundo is one of two sitting board members representing Cook and DuPage counties.

Trustee Hempel asked about the evacuation route proposed for Bengamin School and the possibility for side walks to be incorporated into the route. Discussion occurred and Supervisor Ramey will reach out to the necessary entities to discuss.
