<u>Renee Suwanski of Bartlett</u>: Village of Bartlett Trustee with a passion for the community's health care needs.

John Kinsella of Bartlett: Former DuPage County Circuit Court Judge. Spent over 40 years in his career addressing mental health issues and substance abuses within the community.
